Public Law 87-799

AN ACT

To authorize the Secretary of the Interior to participate in financing the construction of a bridge at Cape Hatteras National Seashore, in the State of North Carolina, and for other purposes.

Be it enacted by the Senate, and House of Representatives of the United States of America in Congress assembled, That in order to facilitate visitor travel within Cape Hatteras National Seashore the N. C. Secretary of the Interior is authorized to pay \$500,000 toward the tion cost, par-cost of construction of a bridge across Oregon Inlet between Bodie ticipation auand Hatteras Islands, in the State of North Carolina, exclusive of any financing for which the project may qualify under the Federal aid to highway laws: *Provided*, That the bridge shall constitute and be maintained as a part of the State highway system.

SEC. 2. The Secretary may make payments on the cost of construction of the bridge referred to in section 1 of this Act only from funds specifically appropriated for that purpose.
