Joint Resolution

To provide for a temporary extension of certain Federal Housing Administration mortgage insurance and related authorities and of the national flood insurance program, and for other purposes.

EXTENSION OF FEDERAL HOUSING ADMINISTRATION MORTGAGE INSURANCE
AUTHORITIES

- SECTION 1. (a) Section 2(a) of the National Housing Act is amended by striking out "June 30, 1977" in the first sentence and inserting in lieu thereof "August 1, 1977". 12 USC 1703.
- (b) Section 217 of such Act is amended by striking out "June 30, 1977" and inserting in lieu thereof "July 31, 1977". 12 USC 1715h.
- (c) Section 221(f) of such Act is amended by striking out "June 30, 1977" in the fifth sentence and inserting in lieu thereof "July 31, 1977". 12 USC 1715l.
- (d) Section 244(d) of such Act is amended by striking out "June 30, 1977" in the first sentence and inserting in lieu thereof "July 31, 1977". 12 USC 1715z-9.
- (e) Section 809(f) of such Act is amended by striking out "June 30, 1977" in the second sentence and inserting in lieu thereof "July 31, 1977". 12 USC 1748h-1.
- (f) Section 810(k) of such Act is amended by striking out "June 30, 1977" in the second sentence and inserting in lieu thereof "July 31, 1977". 12 USC 1748h-2.
- (g) Section 1002(a) of such Act is amended by striking out "June 30, 1977" in the second sentence and inserting in lieu thereof "July 31, 1977". 12 USC 1749bb.
- (h) Section 1101(a) of such Act is amended by striking out "June 30, 1977" in the second sentence and inserting in lieu thereof "July 31, 1977". 12 USC 1749aaa.

EXTENSION OF FLEXIBLE INTEREST RATE AUTHORITY

SEC. 2. Section 3(a) of the Act entitled "An Act to amend chapter 37 of title 38 of the United States Code with respect to the veterans' home loan program, to amend the National Housing Act with respect to interest rates on insured mortgages, and for other purposes", approved May 7, 1968, as amended (12 U.S.C. 1709-1), is amended by striking out "June 30, 1977" and inserting in lieu thereof "August 1, 1977".

EXTENSION OF NATIONAL FLOOD INSURANCE PROGRAM

SEC. 3. Section 1319 of the National Flood Insurance Act of 1968 is amended by striking out "June 30, 1977" and inserting in lieu thereof "July 31, 1977". 42 USC 4026.

EXTENSION OF RURAL HOUSING AUTHORITIES

- 42 USC 1483. SEC. 4. (a) Section 513 of the Housing Act of 1949 is amended by striking out "June 30, 1977" where it appears in paragraphs (b), (c), and (d) and inserting in lieu thereof "July 31, 1977".
- 42 USC 1485. (b) Section 515 of such Act is amended by striking out "June 30, 1977" where it appears in paragraph (b) (5) and inserting in lieu thereof "July 31, 1977".
- 42 USC 1487. (c) Section 517 of such Act is amended by striking out "June 30, 1977" where it appears in paragraph (a) (1) and inserting in lieu thereof "July 31, 1977".
- 42 USC 1490c. (d) Section 523(f) of such Act is amended by striking out "July 1, 1977" where it appears in paragraph (f) and inserting in lieu thereof "August 1, 1977"; and by striking out "June 30, 1977" where it appears in such paragraph (f) and inserting in lieu thereof "July 31, 1977".
